Subject: Deputation Order for Md. Hanif, System Analyst, BARC for enrolling in PhD Course in the University of Tsukuba, Japan

Consequent upon the approval of Ministry of Agriculture (No:12.00.0000.062.19.003.24.481; dated: 30 October 2024), application of Md. Hanif, System Analyst, BARC (dated: 06.11.24), and as per approval of the authority, this order of deputation is issued in favour of Md. Hanif, System Analyst, BARC for enrolling in the PhD Course in the University of Tsukuba, Japan from December 1, 2024 to May 31, 2028 or 42 months from the date of release under the following terms and conditions:

1. The period of stay of the incumbent will be treated as on deputation and he will be entitled to his usual pay, allowances etc. in Bangladeshi currency.
2. All expenses in this connection will be borne by PARTNER PhD Fellowship Program.
3. A release order is to be obtained from the Council before departure.
4. He will inform his name, address, duration of stay etc. to the Embassy of the People's Republic of Bangladesh to Japan with a copy to Executive Chairman, BARC
5. He will have to submit progress report for every six months to EC, BARC and Ministry of Agriculture through proper channel. Failure to do so, will result in suspension of his salary immediately.
6. He will not overstay abroad beyond the approved period as mentioned above without the permission of the authority.
7. Upon completion of the Fellowship Program he will serve in BARC for a minimum period of 6 (six) years and will have to execute bond in this regard.
8. He will submit a report within 7 days of his return about what he learned during PhD program.
9. He must submit a copy of his PhD dissertation to BARC and Ministry of Agriculture through proper channel at the end of his PhD research.
10. He must return to Bangladesh in due time, otherwise he will have to refund all salary and allowances paid in deputation period and also compensate Tk 6.0 (six lac) to BARC according to the bond.
11. He will have to follow all the rules mentioned in the Public Administration Training and Higher Education Policy, 2023 and comply with all terms and conditions as mentioned in the deputation approval letter of the Ministry of Agriculture and the bond signed with PARTNER-SMC, BARC.
