

Government Order (G.O)

 - c. He will not be allowed to stay abroad beyond the approved period;
 - d. He will be bound to follow all the rules and regulations of Bangladesh Academy for Rural Development (BARD) & the Bangladesh Government about training abroad;
 - e. He will submit the necessary documents to the Administrative Ministry after his arrival in Bangladesh.
3. This order is issued with the approval of the competent authority.


