Above mentioned issues and subject, the deputation of Afroza Begum (BARI0621), Senior Scientific Officer, Entomology Division, BARI, Gazipur has been granted for studying Ph.D at University of Auckland, New Zealand from 20/12/2025 to 30/06/2028 or the total period will be 02 years 06 months 12 (Twelve) days from the date of starting deputation on 14/02/2026 to 25/08/2028 under the following terms and conditions:

a. The terms and conditions:

1. She will be considered as 'on duty' during the entire period of deputation and travelling.
2. She will be entitled usual salary and other benefits in Taka during deputation.
3. After deputation period, as per bond, she will be bound to serve this institute for at least 06 (Six) years from the date of joining.
4. All expenditure will be beared by APCU-BARC, PARTNER.
5. She will have to report to Bangladesh Embassy in New Zealand within seven days of her entrance in New Zealand.
6. She must not overstay abroad beyond the deputation period.
7. She will submit her academic progress report in every six months as per BARI proforma.
8. She must inform the institute about the full address of correspondence with phone and e-mail of her major professor along with herself just after arriving.
9. After return, she must submit three copies of report in the prescribed form of Ministry of Public Administration on higher study along with the joining letter with 02 (two) dissertation copies to the Director General through proper channel.
10. The Officer-in-Charge will take over all official goods from her before release and inform Director (T&C) Wing, BARI, Gazipur.
11. In case of a Ph.D degree, upon completion of the course, an application must be submitted to the ministry along with a copy of the thesis and the certificate to obtain the doctorate title.
12. She must abide by other government rules in this connection.
