About the Project:

Human Resources Development and Capacity Building (HRD & CB) project is a project initiated by the Bangladesh Bridge Authority (BBA) to equip the officers and staff of BBA with required professional skills to meet the challenges of day to day activities. The total estimated cost of the project is Tk. 1351.59 lakh and the implementation period is from July 2017 to June 2020. A total of 141 training courses in 15 different categories as in-house training, 67 day or short courses, 20 seminars and workshops would be organized under the project.

Moreover, 88 officers in 11 batches would be sent to training institutions of international reputation for overseas training. 60 officers in 12 batches would be sent for study tour to visit world-class infrastructures of importance to gain relevant knowledge. And professional training from specialized institutions for 15 officers in 3 batches is underway. Under this project, trainees are nominated from different projects of BBA. In addition, experienced trainers from different ministries and departments of the government are invited as resource person for conducting various trainings.

2.1. Objectives of the Project:

- To increase the efficiency and competence of the officers of BBA in formulating and implementing infrastructure development projects;
- To improve e-service by enhancing the efficiency of BBA officials and utilization in line with the Digital Bangladesh Program of the government;
- To develop qualitative and quantitative competency of BBA employees by enhancing skills in their respective field;
- To interact and exchange knowledge and experience in between officials, public representatives, private sector and civil society regarding reforms of government, good governance and professional matters.

2.2. Overview of the Project:

- The first program titled “National Integrity Strategy (NIS)” was held on 29th August’2017.
- 119 training sessions on diverse topics have been arranged until February’2020.
- 41 seminars and workshops have been arranged during the project period.
- 15 overseas trainings have been completed under the project.
- A sum of 6,181 trainees from different wings and background attended the trainings, seminars and workshops arranged by the HRD & CB project until February’2020.
- In-house training program of around 45,538 hours has been executed by the HRD & CB project until February’2020.

- 87 participants attended the overseas training programs organized by the HRD & CB project up to February'2020.

3. Progress in implementing in-house training:

Under the HRD & CB project, subject based training aligned with the needs of the Administration, Finance and Accounting, Planning and Development and Technical wing of BBA is being provided.

Yet again, training is being offered on the issues of Annual Performance Agreement as well as Ministry of Public Administration. As of February 2020, 160 trainings, seminars and workshops on various topics have been organized as the following:
