

The content of the Jingles will be finalized and provided as per project team instructions. c) The firm will be responsible to make all arrangements for conducting TV Talk Show in selected TV Channels. The list of TV channels as well as specified timeline will be decided by Project Authority. d) The firm will be responsible to make all arrangements for telecasting TV PSA in selected TV Channels within specified timeline. The list of TV channels will be selected by project authority. e) The firm will be responsible to make all arrangements for broadcasting Radio Commercial-RDC in selected Radios within specified timeline.
