Executive Summary

Bangladesh Bureau of Statistics (BBS) compiles and publishes Foreign Trade Statistics (FTS) on a regular basis. This publication presents monthly trend of Bangladesh foreign trade statistics on top trading partners, essential import commodities and last twelve months scenario of major export and import goods specially for November, 2023.

Merchandise trade data of this publication are provided by National Board of Revenue (NBR) while data on services from Bangladesh Bank. Data presented in this publication are provisional and subject to revision. All these provisional data will be subsequently reviewed and revised. Revised data are being presented in next issues.

In November, 2023 total export and import of goods and services is recorded at increased by Tk. 608.43 and decreased by Tk.915.65 billion respectively resulting in a trade deficit at goods and services of Tk. 307.22 billion. The growth of export and import in November, 2023 increased by 7.63 and decreased by 2.10 percent respectively comparing to October, 2023 and it is increased by 7.37 and decreased by 9.18 percent respectively comparing to November, 2022.

For the three months ending in November, 2023 the average of export of goods and services was Tk 582.79 billion, while the moving average of import of goods and services was Tk.915.09 billion resulting in an average trade deficit of Tk.284.86 billion. For the three months ending in October, 2023 the average trade deficit was Tk. 284.86 reflecting average exports of Tk. 574.18 billion and average imports of Tk. 859.15 billion.

Indicators of this publication are expected to provide a good idea about the trend of export and import of the country over the previous months of a year. This monthly release would be a useful document for planners, policy makers, researchers, development partners/agencies, academicians and other stakeholders.

Graph 01. Export and Import By Month

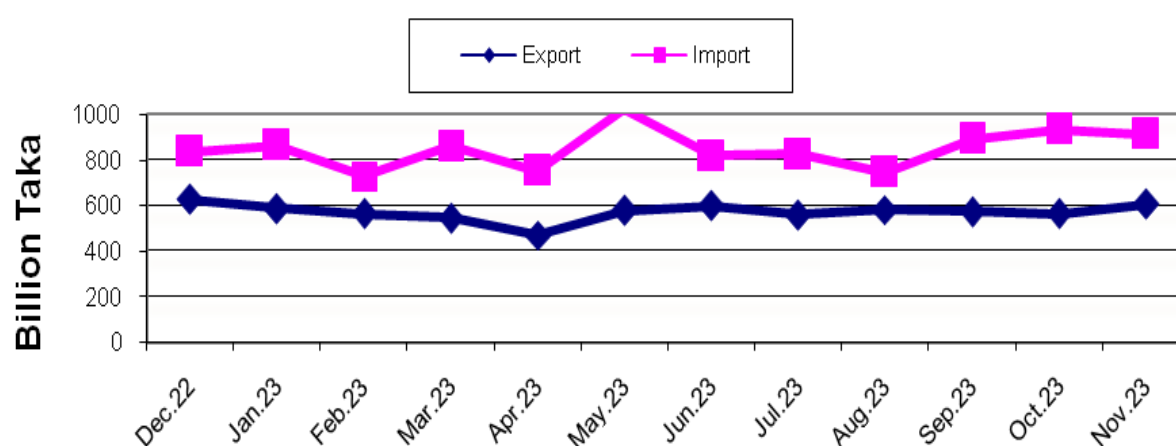

Graph 02. Export and Import By Month

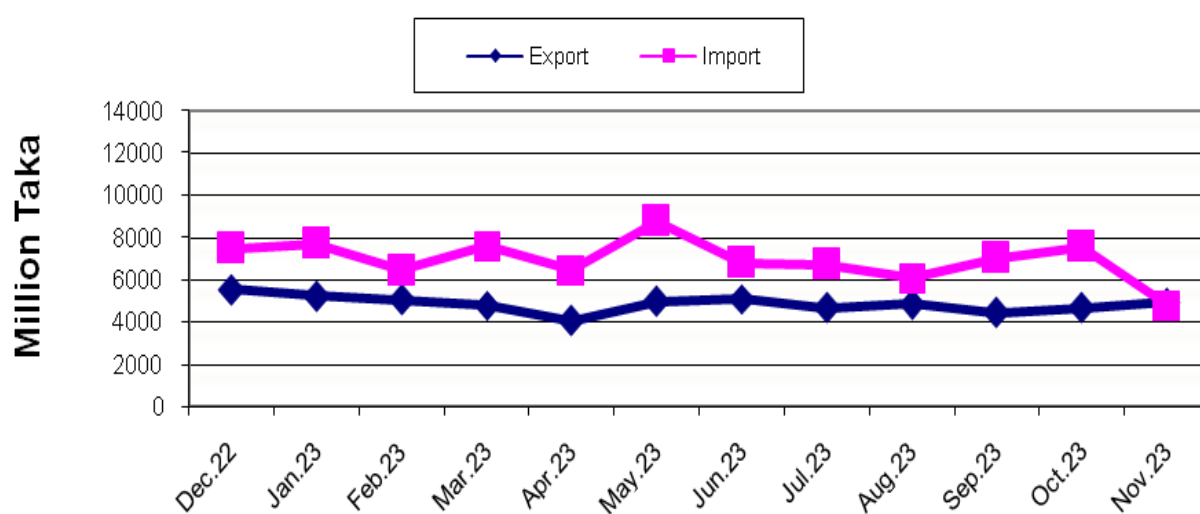

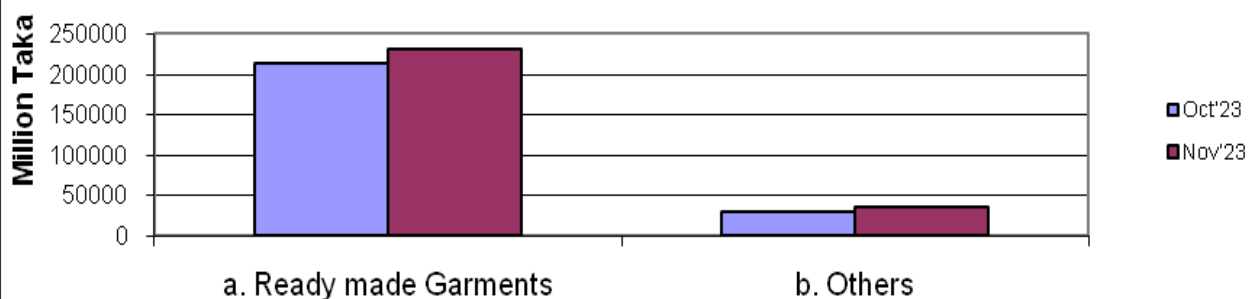
Graph 03: Export of redymade garments and others in Oct'23 & Nov'23

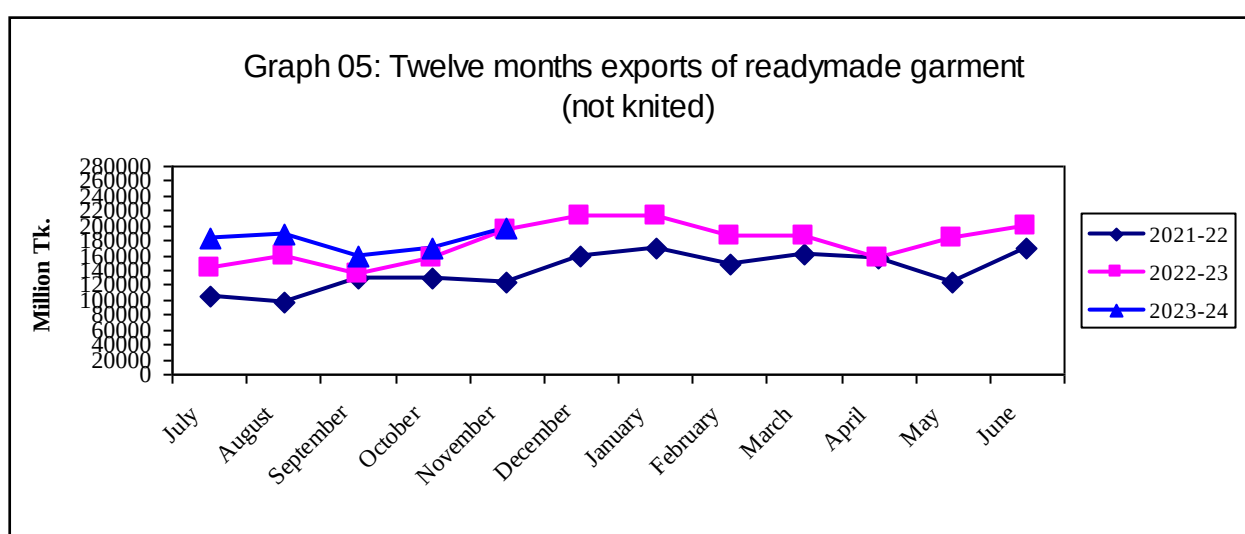
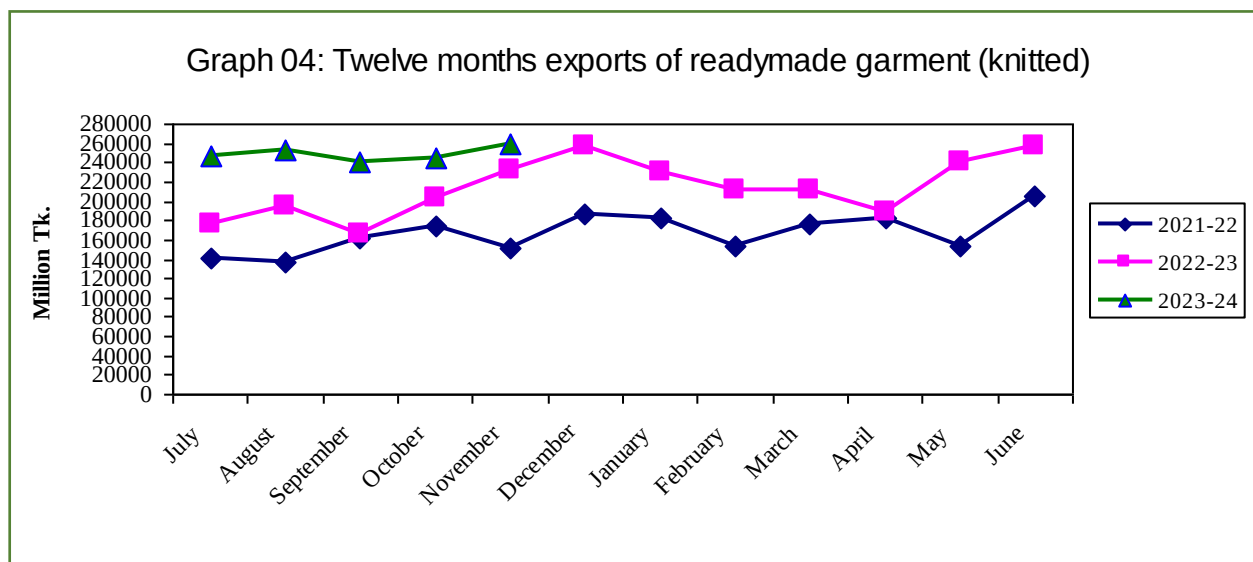

Graph 06: Twelve months exports of raw hides,skins & leather

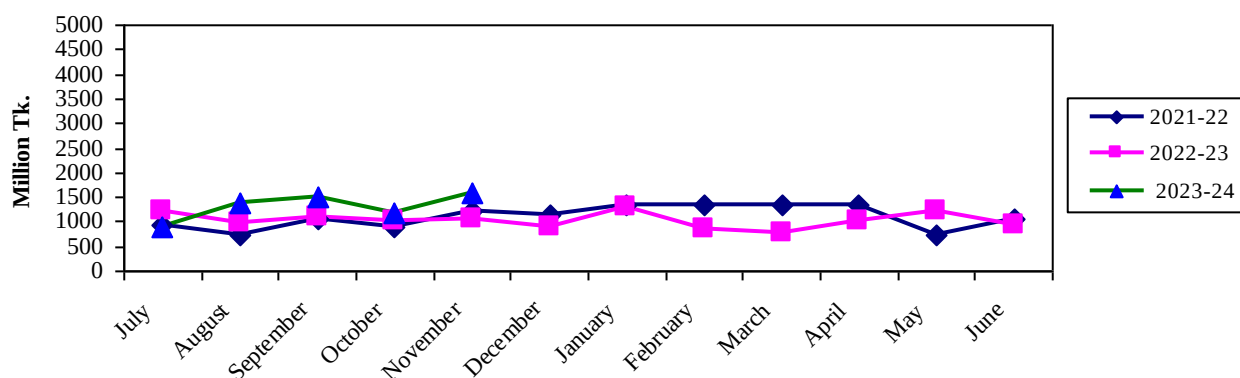

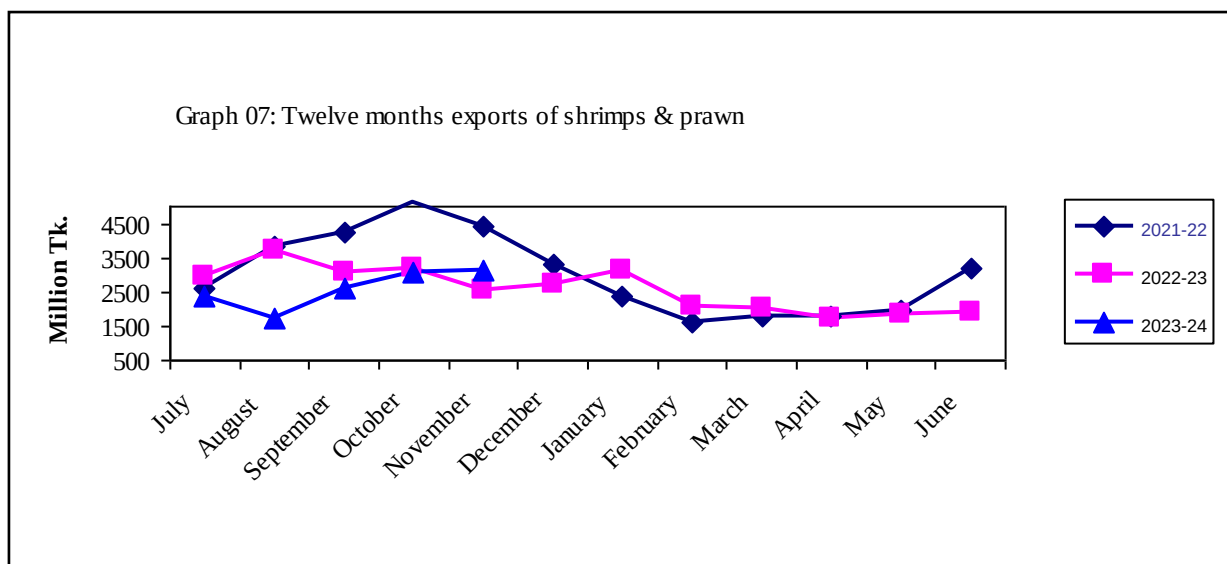

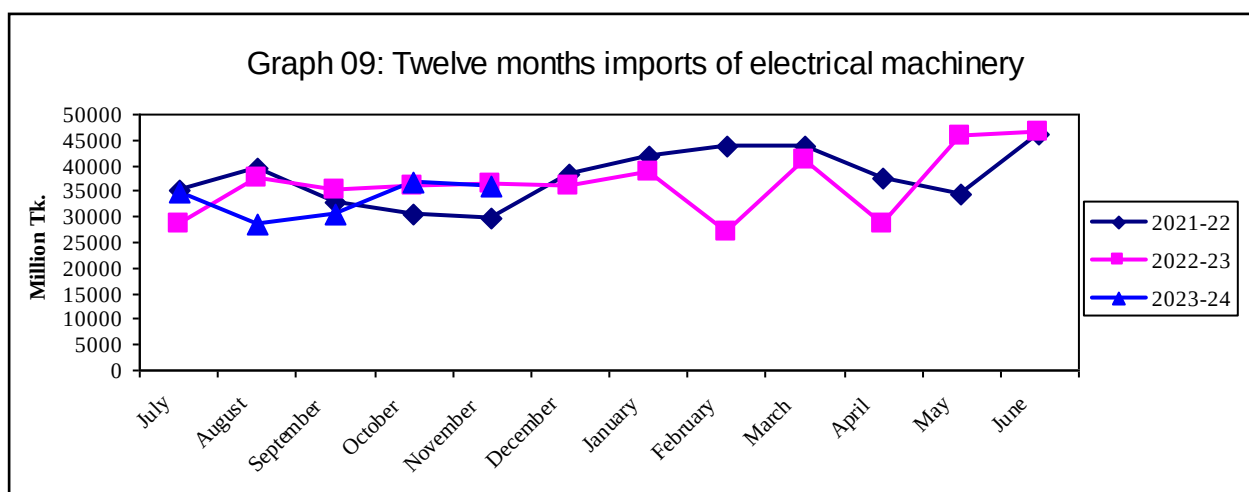
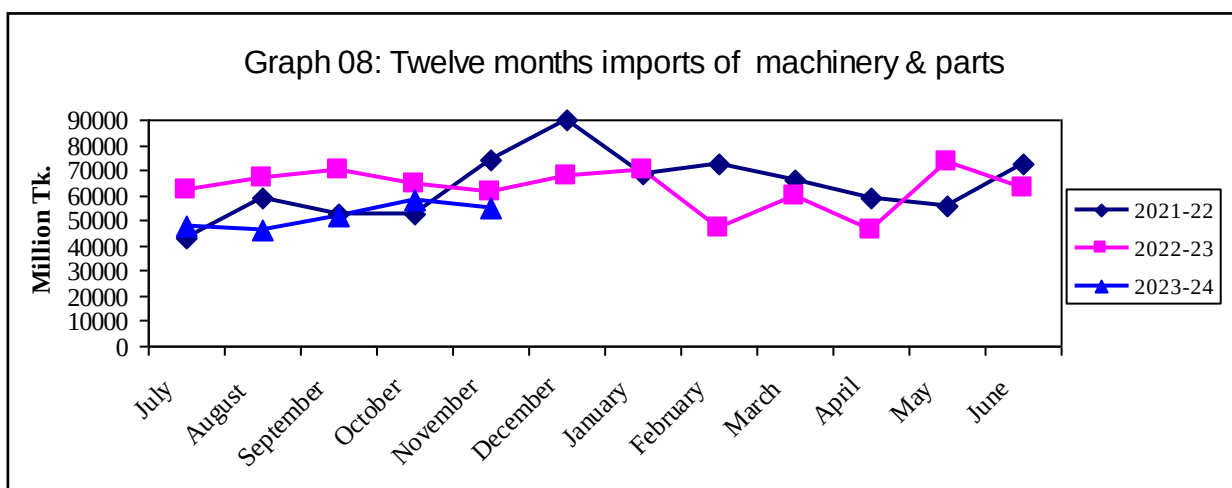
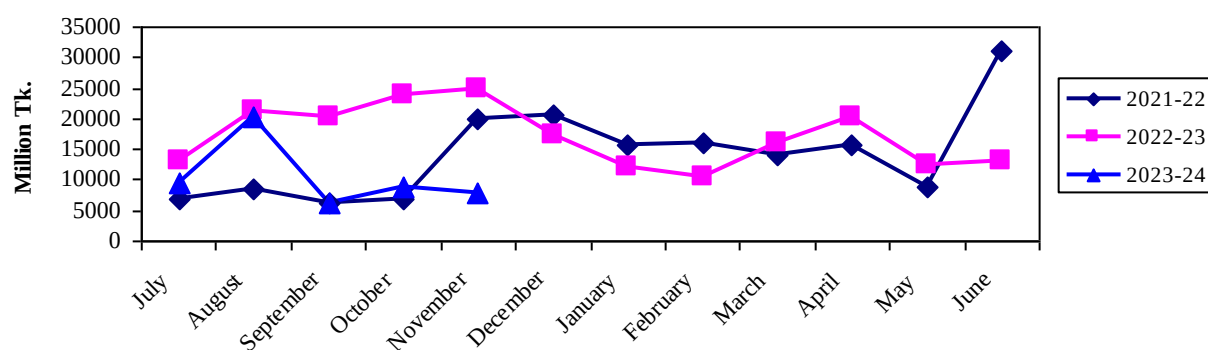

Graph 11: Twelve months imports of palm oil

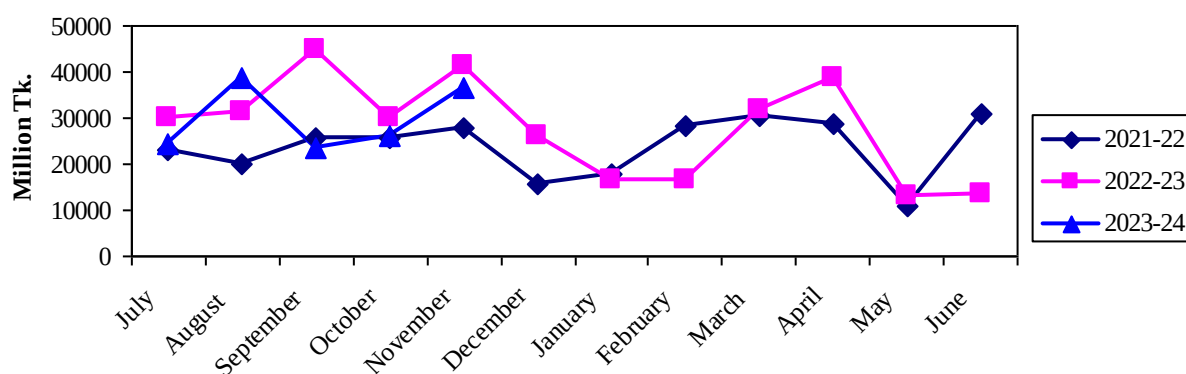
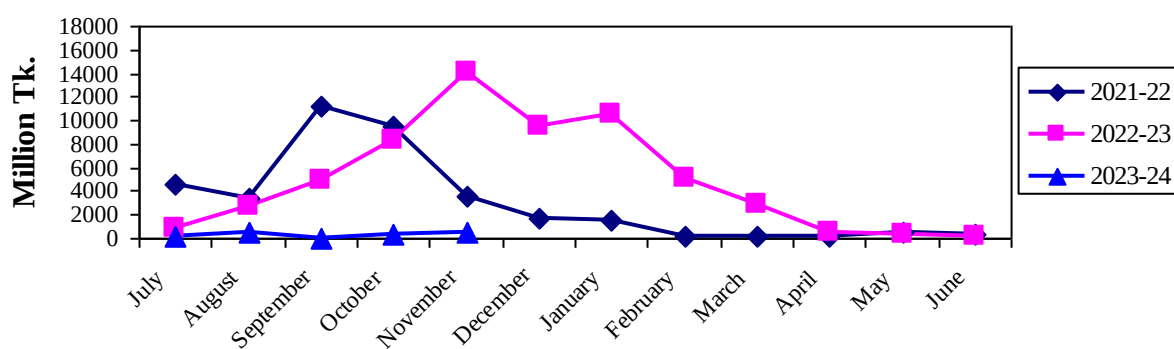

Graph 13: Twelve months imports of wheat

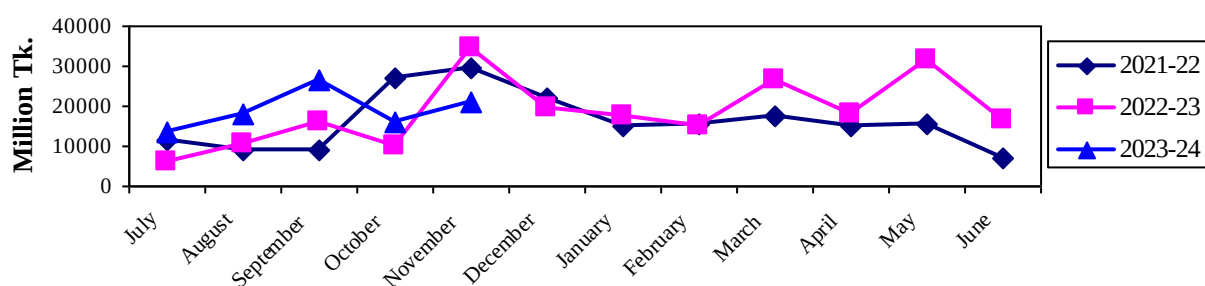

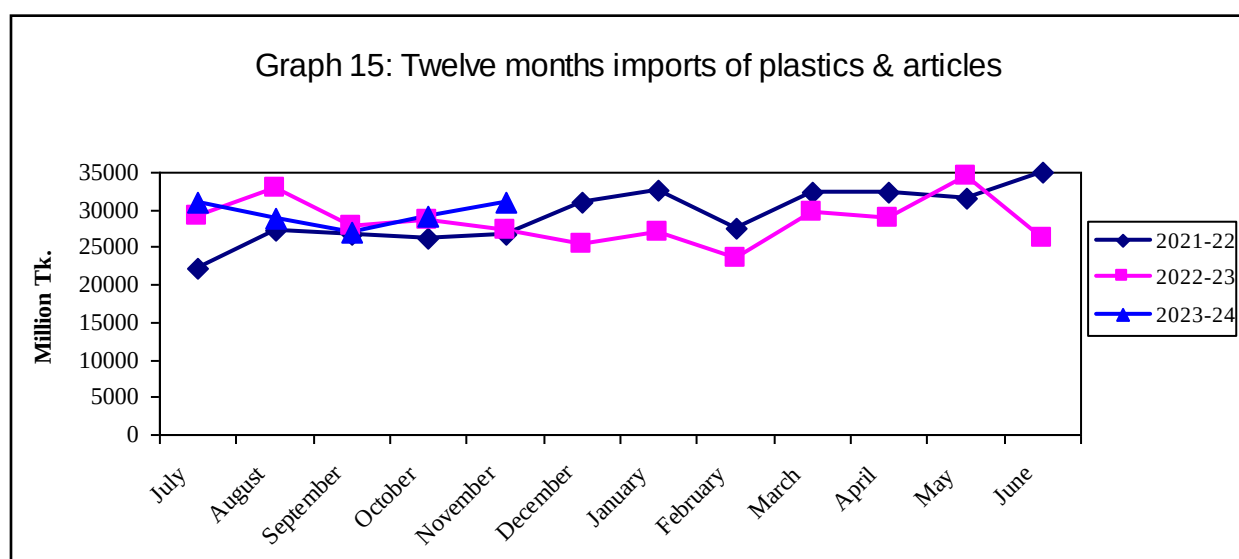
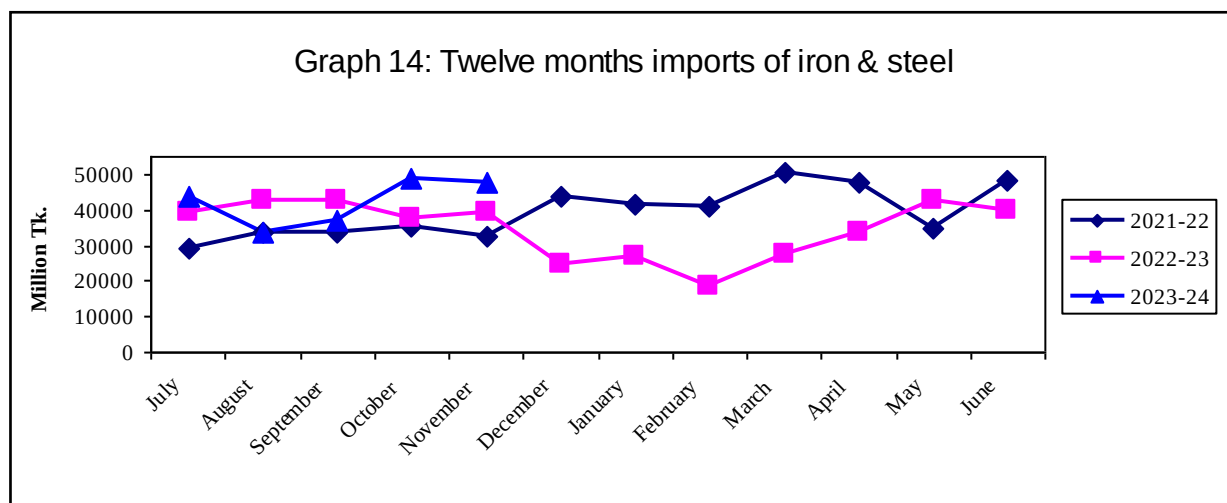

Graph 16: Top trading partners – total trade (goods), November-2023.

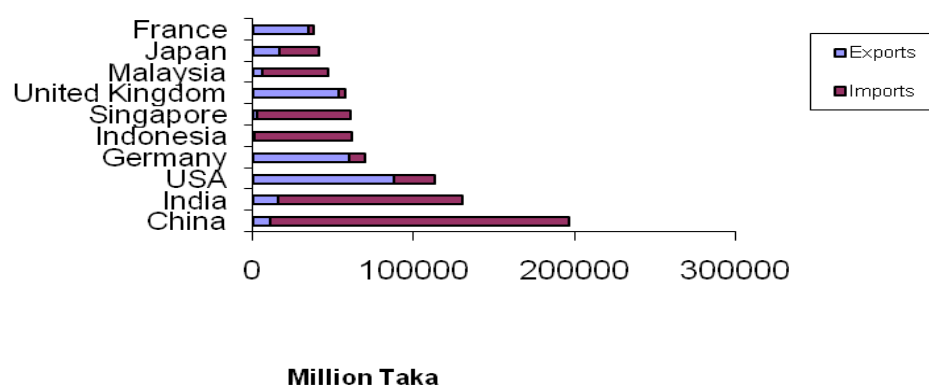
