



Industry and Labour Wing


Functions of the Wing

- To generate labour market indicators through Labour force survey (LFS)
- To develop and update Business Register (BR)
- To conduct Survey on Manufacturing Industries (SMI)
- To conduct Establishment and Institutional Survey (EIS)
- To develop National Statistical Classifications (Industry, Occupation and product) (BSIC, BSCO, BCPC)
- To generate informal sector statistics (ISS)
- To generate ICT Indicators (Access and use at household and individuals level)
- Other ad-hoc activities /surveys.
