Every census and survey had methodologies based on which the entire operation was conducted and that resulted into micro datasets. BBS has initiated this project with the objective of transforming these historical data into Metabase so incumbent and potential stakeholders as well as interest groups can get access to these data for their need of research, study and various publications. To better manage and facilitate, BBS needs a robust and efficient database and web based front-end platform through which they can: a) Preserve these micro datasets along with metadata, questionnaire & publication etc. b) Search and retrieve these micro datasets as & when required based on BBS's defined metadata. • (Firms) needs to be create Metadata for each and every Census/Surveys Microdata using existing i) COBOL programming data layout/structure/dictionary and ii) Publication of the corresponding Census/Survey, which will be provided by the project authority.
