Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of North Bengal Paper Mills Limited ("the Company"), which comprise the statement of financial position as at 30 June 2021, and the statement of profit or loss and other comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Company as at 30 June 2021, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs).

Basis for Opinion



Notes to the Financial Statements

1.00 The company and its operation

1.01 Legal Status

The project was established before liberation under the supervision of erstwhile EPIDC. Following upon Liberation, subsequently, the Management of the project was vested to BCIC. On 6th October 1980 BCIC formed a private Company Limited by shares bearing Registration # C-8413 under the Companies Act 1913 as project of the later. Since then the management of the company run by a Board of Directors time to time constituted by BCIC.

1.02 Aims and objectives

The Company was established with a view to mainly producing of writing papers printing paper and duplicating paper from

1.03 Present status of the Company

With reference to letter No. 36.00.0000.062.99.014.20.59, dated 19th January 2021 from Technology Ministry of Bangladesh it has been decided that due to safety of Rangpur Nuclear Power Plant with the blessing from The honorable Prime Minister of Banglaesh, Bangladesh Chemical Industries Corporation has been ordered to hand over the land of North Bengal Paper Mills Ltd. to the Technology Ministry for a token money of Taka 100.51 build the base for the Army to protect the Nuclear Power Plant. The mill was previously close from 2002, from operation complying the memo of Ministry of Finance No. AM/BA-2/Interest free loan(1)/98(Part-1)/1(3) dated 21.10.2002 and in conjunction with the memo of Ministry of Industries. SIM/SAS-1/Misc.-15/2002/339 dated 29.10.2002.
