
Office Order

Subject: Approval of deputation for enrolling on PhD course in Murdoch University, Australia.

With reference to the above-mentioned, subject the undersigned is directed to inform that Lailatul Ferdousi, Senior Scientific Officer, BCSIR Laboratories, Rajshahi is granted 3(three) years 6(six) months deputation for enrolling on PhD course in Agriculture, Environmental and Related Studies under Murdoch University, Australia from the date, 27.05.2024 or from the date of handing over the charge, but not before the date 27.05.2024, for 3(three) years 6(six) months under the following terms and conditions:

1. BCSIR or Bangladesh Government will have no involvement in any sort of financial expenditure in this regard;
2. She will be treated as on duty during deputation and her salary will be paid in Bangladeshi currency;
3. She will have to return Bangladesh as soon as the deputation is over and will not overstay;
4. She may apply for an extension of her deputation for the period of her scholarship provided that she is awarded further scholarship;
5. She will have to work at least 8 (eight) years in this organization after completion of the course;
6. Prior to Leaving Bangladesh, attested copies of Visa and passport, foreign address, E-mail and letter of Departure should be submitted to competent authority;
7. She must return to Bangladesh in due time otherwise she will have to refund her salary and allowances paid in deputation period and she will also have to compensate taka 8 (eight) lacs to the BCSIR according to bond.
8. During deputation period it is required to follow all the rules and regulations of "Public administration training and higher studies guideline 2023."
