3. Under no condition the approval will be extended. If the extension of approval is urgent, the application will have to be forwarded through the concerned Bangladesh High Commission Office.
4. He will draw his usual pay and allowances from Bangladesh in local currency.
5. He must return to the country within the stipulated time limit & inform the concerned authority.
6. This order is issued with the approval of competent authority.
7. This order will remain valid under Rule No 34 of BSR.
