9	Brief Description of Assignment	:	<p>Bangladesh Freedom Fighters' Welfare Trust was established in 1972 by the President's Order No. 94/1972 for the welfare of the war wounded freedom fighters and the families of the martyred heroic freedom fighters, who participated in the great war of independence of Bangladesh. In 1972, 18 establishments (09 industrial and 09 commercial) were handed over to the Trust on behalf of the Government of Bangladesh. Later 11 industrial establishments in 1978, 01 in 1986 and 02 in 1989 were handed over to the trust by the government. Besides these, 04 industrial unit were established by trust's own initiative. The total number of commercial and industrial establishment is 36.</p> <p>07 establishments were taken back by the government in the financial year 1982-83 due to liabilities and 8 establishments were converted into 3 establishments due to continuous losses. Out of the remaining 24 establishments, some establishments have been divided into multiple plots. At present the number of establishments and plots has now increased to 34.
