



Conditions:

1. The above mentioned animal will have to import through Hazrat Shahjalal International Airport, Dhaka.
2. Imported animals must be kept in cages, so that they could not come in contact with any other animals.
3. Imported animals will be exhibited only in Dulahazara Safari Park, Cox's Bazar.
4. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
5. This NOC is not transferable and import of wild animal is strictly prohibited.
6. Imported animals and mentioned microchip number of each imported species must be verified by a forest officer immediate after reach at Hazrat Shahjalal International Airport before leaving the Airport premises.
7. This NOC is issued for one consignment only.
