- Imported cage birds cannot be released in nature.
- Dead birds must be buried deep in the ground.
- After import, rings must be worn on the legs of imported birds within 7(seven) days and inform the licensing authority.
- This NOC is not transferable and the import of wild birds is strictly prohibited.
- This NOC is issued for one consignment only.
