**Conditions:**

1. The above mentioned animal trophies will have to import through Hazrat Shahjalal International Airport, Dhaka.
2. Imported animal trophies must be kept in houses.
3. The above-mentioned animal trophies can not be sold or transferred to other person/institution for any purposes.
4. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
5. This NOC is not transferable and export or re-export of wild animal trophies are strictly prohibited.
6. Imported animal trophies of each imported species must be verified by a forest officer immediate after reach at Hazrat Shahjalal International Airport before leaving the Airport premises.
7. This NOC is issued for one consignment only.
8. After importation of these trophies, importer will have to register by following the clause 27 of the Wildlife (Conservation and Security) Ordinance, 2026 under the relevant forest division/Wildlife management & nature conservation division.
