3. Bidders may bid for one or several contracts as mentioned in paragraph-1 and further defined in the bidding documents of the packages. Bids for each contract will be evaluated separately.

Bidding will be conducted through the National Competitive Bidding (NCB) or procedures as specified in IsDB's Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing including Procurement 'Policy and Procedures' Effective April 2019-Revised February 2023 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to 1.9.1-1.9.5 paragraphs of the Procurement Policy of the Procurement Guidelines setting forth IsDB's policy on conflict of interest.
