The Digital Entrepreneurship and Innovation Eco-System Development Component of PRIDE Project of Bangladesh Hi-Tech Park Authority (hereinafter called "Borrower") has received loan from International Development Association (IDA) in the form of a Credit (hereinafter called Credit) toward the cost of Digital Entrepreneurship and Innovation Eco-System Development Project under PRIDE Project. 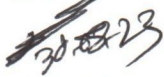
