

Office order

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh for 36 (thirty six) months of deputation in favour of Tasnima Mahjabin (passport no- (BG0004135), Principal Scientific Officer of Bangladesh Institute of Research and Training on Applied Nutrition, Arai hazar, Narayanganj to study the Doctor of Philosophy (PhD) course under the Mahidol University, Thailand from the 22 December 2025 or from the date of charge handover under the following terms and conditions:

- a) While studying in the PhD course including travel time, she will be treated as on deputation;
- b) She will draw her pay and allowance in local currency; no part of it shall be drawn in foreign currency;
- c) Before going abroad, she will give the bond following the rules;
- d) The duration of the scholarship will be a maximum of 36 (thirty six) months;
- e) Expenses related to PhD study will be borne by Partner, APCU-BARC under PARTNER PhD Fellowship
- f) The candidate will not be eligible to receive any scholarship from other sources during the study period;
- g) She will submit a yearly progress report with attestation of the related supervisor through the proper authority to the Agriculture Ministry of Bangladesh;
- h) In the case of enjoying the approved deputation, the provisions of the Public Administration Training and Higher Education Policy, 2023 shall be applicable.
- i) She must submit a final copy of dissertation/thesis and PhD Certificate at the Ministry of Agriculture and BIRTAN immediately after completion of the PhD program; and
- j) The other rules of government related to the deputation will apply here.


