The People's Republic of Bangladesh has received financing from the World Bank toward the cost of the "Bangladesh Regional Waterway Transport Project-1(BRWTP-1)" and intends to apply part of the proceeds toward payments under the contracts for the procurement of Hydrographic Survey and Related Equipment.
2. Bangladesh Inland Water Transport Authority (BIWTA) under Ministry of Shipping, Government of the People's Republic of Bangladesh now invites sealed bids from eligible Bidders for supply of Hydrographic Survey and Related Equipment under three Lots of contract mentioned below.

Quantities, locations of supply and delivery period in detail have been described in the bidding document.

3. The bidding document describes three types of **Equipment and Related Services** to be procured under above three (3) Lots- each Lot will be treated as separate contract. The Bidders may bid for any number of Lots as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid. The Bidder shall have required eligibility and qualifications as stated in the Bidding document.

4. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits and Grants by World Bank Borrowers, version January 2011/ revised July 2014 ("Procurement Guidelines")*, and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
5. Interested eligible bidders may obtain further information from Mr. Mahmud Hasan Salim, Project Director, Bangladesh Regional Waterway Transport Project 1 (BRWTP-1), BIWTA and inspect the bidding documents during office hours from 09:00 to 17:00 Hours BST (GMT+6) at the Office of the Project Director at the address given below.
6. Interested eligible bidders may purchase a complete set of bidding documents in English upon the submission of a written application through letter or email to the address below and upon payment of a non-refundable fee of 8,500.00 in Bangladesh Taka or 100.00 in US Dollars for the cost of the bidding documents which the bidders may collect from the office address below during office working hours. Bidders who would like the bidding documents to be delivered to them through courier service should request this in their application and also pay an additional fee of 1,500 Bangladesh Taka for local delivery within Bangladesh (i.e. total 10,000.00 Bangladesh Taka), or additional 100.00 US Dollars (i.e., total 200.00 US Dollars) for overseas delivery outside Bangladesh. The method of payment will be Cashier's Check or Bank Draft/Pay Order in favor of "BRWTP-1" or electronic wire transfer to the Purchaser's bank account provided below (electronic wire transfer should indicate the name of the bidder and state "Payment for purchase of bidding document for Package G-2". In case of courier service delivery requested by the bidder, the Purchaser will dispatch the bidding document to the bidder through courier service within three business days of receipt of a written application and the above-specified payment. The Purchaser shall not be responsible for any delays or problems in delivering the bidding documents by the courier service provider.
7. Bids must be delivered to the address below on or before 14:00 Hours BST (GMT+6), 28 June 2021. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on 28 June 2021 at 14:30 Hours BST (GMT+6). The bid opening meeting will also be connected through video conference, for which the connection details will be sent through email at least five business days before the bid opening date to the bidders who submitted the written application and purchased the bidding document. No bidding document will be issued from the Office of the Project Director on the date of the bid submission deadline.
