# 1. Description of the Governance Problem

A project has been adopted by the ministry to provide employment to unemployed family members of the valiant freedom fighters.

## **Causes of the Problem:**

- The project aims to create employment; but it is not happening.
- The allocated funds are not being used properly.
- A large number of people are remaining unemployed.

## **Result:**

I want to ensure employment for at least 50 people as a pilot.

## **2. Description of the Reform Initiative**

To eliminate unemployment through suitable employment by providing training through employment generating training institutions in the respective districts based on the location and interests of the beneficiaries.

# 3. Proposed Statistics for Reform Initiatives

**(a) Title of the pilot reform initiative:**

Alleviating unemployment by providing suitable job-oriented training to Son and Daughters of valiant freedom fighters receiving allowances.

**(b) Which institution will implement the initiative?**

The initiative will be implemented through formal and informal training conducted by the training institutions of the Department of Youth Development at the district and upazila levels.

**(c) Where will the piloting take place & What is the rationale for considering piloting?**

The piloting will take place in Jamalpur district because the unemployment rate in this district is very high.

**(d) When will the piloting start and end?**

The piloting will start on May 15, 2025 and end by July 15, 2025.

**(e) How many people will benefit from the piloting and how much money will be saved?**

The piloting will provide suitable employment to at least 50 people; rather than saving money, it will create opportunities for individuals to earn income.

# Stakeholder Analysis & their Management)

- Son and Daughters of valiant freedom fighters receiving allowances as trainees.
- District and Upazila level trainers of the Department of Youth Development who will provide training in various trades.
- Under my supervision, one Deputy Secretary of the Ministry of Liberation War Affairs will continuously monitor this training and ensure self-employment.

# Resource Mobilization

- To develop unemployed Son and Daughters of valiant freedom fighters into self-employed people by providing them with various types of training.
- For their training needs, the Department of Youth Development allocates funds (if necessary) for training. As a government institution, the Department of Youth Development provides training free of charge.
- Use of various training centers of the Department of Youth Development.
