The People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) toward the cost of **“Pre-payment Metering Project in four Distribution Zones of BPDB”** Project of BPDB under Power System Efficiency Improvement Project of Asian Development Bank (ADB). Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The Bangladesh Power Development Board (“the Employer”) invites sealed bids from eligible bidders for **Design, Manufacture, Supply, Installation, Testing & Commissioning of Single and Three Phase Smart Pre-Payment Meters, Data Concentrator Unit (DCU), Hand Held Unit and Customization Center with 3 years related support services on turnkey basis in Chattogram Zone** (“the Facilities”) under Package No. PPMS-G-1(GD-1). A brief description of the type of scope including the delivery/completion period are as below:

3. Open competitive bidding will be conducted in accordance with ADB's Single-Stage: Two-Envelope methods and is open to all bidders from eligible countries as described in the Bidding Document.

4. Bidders (Individual/Joint Venture) interested to participate have to meet among others the following qualification criteria:
- a. **Average Annual Turnover:** Minimum average annual turnover of US \$21.50 million or equivalent amount calculated as total certified payments received for contracts in progress or completed, within the last 3 (three) years.
 - b. **Financial Resources:**
 - For Single Entities:**
The Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of is US \$ 3.5 million or equivalent.
 - For Joint Ventures:**
 - (1) One partner must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its own current contract commitments defined in FIN - 4, meet or exceed its required share of 40% from the total requirement for the Subject Contract. AND
 - (2) Each partner must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its own current contract commitments defined in FIN - 4, meet or exceed its required share of 25% from the total requirement for the Subject Contract. AND
 - (3) The Joint Venture must demonstrate that the combined financial resources of all partners defined in FIN - 3, less all the partners' total financial obligations for the current contract commitments defined in FIN - 4, meet or exceed the total requirement for the Subject Contract of US \$3.5 million or equivalent.
 - c. **Contracts of Similar Size and Nature:** Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one contract that has been successfully or substantially completed within the last 7 years and that are similar to the proposed contract, where the value of the Bidder's participation exceeds US \$17.00 million or equivalent. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements).
