- ii. furnish a Performance Security in the specified format and in the amount of **BDT 28,973,405 (BDT Twenty-eight million nine hundred seventy-three thousand four hundred five) & USD 549,170 (USD Five hundred forty-nine thousand one hundred seventy)** for the initial year of the Construction Period and the second one shall be submitted for the remainder of the Construction Period upon the expiration of the first one, preferably within Twenty-one (21) days from issue of this Notification of Award but not later than **25 January 2026**, in accordance with ITT Clause 66.2
- iii. sign the Contract within twenty-eight (28) days of issuance of this Notification of Award but not later than **25 January 2026**, in accordance with ITT Clause 69.2

You may proceed with the execution of the supply of **Installation of 18 MW (AC) grid tied solar power plant near to Hathazari 230/132/33 kV Grid Sub-Station & Supply of Electrical Energy**, only upon completion of the above tasks. You may also please note that this Notification of Award shall constitute the formation of the Contract, which shall become binding upon you.
