**<sup>1</sup>[B. Bridges Division:]**

- <sup>2</sup>[1. All matters relating to planning (including feasibility study) implementation, monitoring and evaluation of construction of bridge, elevated expressway and tunnel of 1500m or over, subway, toll road, flyover, expressway, causeway, link road, etc.
2. Undertake steps to secure required funds from external and internal sources including Public Private Partnership (PPP) for the implementation of such plan.
3. Take all necessary steps to enter into agreements with various agencies for securing funds for the implementation of the bridge, elevated expressway, subway, tunnel and other projects subject to the approval of the Government.
4. Enter into contracts/agreements with contractors and consultants as approved by the Government for the execution of different components of such projects.
5. Operation and maintenance of constructed structures and allow other agencies like Bangladesh Railway, Gas Transmission Company Limited (GTCL), Power Development Board (PDB) and Bangladesh Telecommunications Company Limited (BTCL), mobile operators, etc. to operate and maintain their facilities located within the designated area and enter into contracts with concerned agencies including private concerns for these purposes.
6. Determine and collect tolls and fare for various classes of traffic using bridge, elevated expressway, subway, tunnel, toll road, etc.
7. Take steps to secure and control development within the designated areas and controlled zones at the entry and exit terminal ends of the bridge, elevated expressway, subway, tunnel and other establishments relating to subjects allotted to this Division.
8. Employ and use traffic officers and other officials to enforce the by-laws, collect tolls and carry out such duties as the Division may consider necessary to discharge its functions.
9. Appointment, promotion and administration of all officers and staffs in National Pay Scale grade 10-20.
10. Liaison with International Organisations and matters relating to treaties and agreements with other countries and world bodies relating to subjects allotted to this Division.
11. All laws on subjects allotted to this Division.
12. Formulation of policies regarding subway network system.
13. Inquiries and statistics on any of the subjects allotted to this Division.
14. Fees, fare and tolls in respect of any of the subjects allotted to this Division except fees taken in courts.
15. Secretariat administration including financial matters.
16. Administration and control of subordinate offices and organisations under this Division.
17. Matters relating to Bangladesh Bridge Authority.
18. Issuing license for the construction, maintenance and operation relating to subjects allotted to this Division.]
