1. The **Sadharan Bima Corporation** has been legally entitled to issue reinsurance coverage of In-Orbit Insurance of Bangladesh Satellite Company Limited(BSCL). And in this way Sadharan Bima Corporation intends to get reinsurance coverage from the interested Reinsurance brokers/Quotationer for which this Quotation Document is issued.
2. No Securities such as Quotation Security (i.e. the traditionally termed Earnest Money, Tender Security) and Performance Security shall be required for submission of the Quotation and execution of the services (if awarded) respectively.
3. Quotation in sealed envelope or through electronic mail (masum.hossain@sbc.gov.bd) shall be submitted to the office of the undersigned **on or before 11 June, 2024 BST 16:00** hrs. The envelope containing the Quotation must be clearly marked "Quotation for **Reinsurance Coverage for BSCL**, and Quotations received later than the time specified herein shall not be accepted.
4. The Procuring Entity may extend the deadline for submission of Quotations on justifiably acceptable grounds duly recorded subject to threshold of Twenty One (21) days pursuant to Rule 71 (4) of the Public Procurement Rules, 2008 of Bangladesh.
5. Quotation shall be submitted as per Bill of Quantities.
6. All Quotations must be valid for a period of at least **30 days** from the closing date of the Quotation.
7. No public opening of Quotations received by the closing date shall be held.
8. Quotationer's rates or prices shall be inclusive of profit and overhead and, all kinds of taxes, duties, fees, levies, and other charges to be paid under the Applicable Law if the Contract is awarded.
9. Rates shall be quoted and, subsequent payments under this Contract shall be made in EURO currency.



10. Quotationer shall have legal capacity to enter into Contract.
11. Quotations shall be evaluated based on information and documents submitted with the Quotations, by the Evaluation Committee.
12. In case of quotation submitted on Lump-sum basis, if anomalies found between figures and words, the words will prevail. Quotationer shall remain bound to accept the arithmetic corrections made by the Evaluation Committee.
13. The execution of services should be completed as per guidelines attached herewith.
14. Successful Quotationer will be informed after completing all the formalities.
15. The Procuring Entity reserves the right to reject all the Quotations or annul the procurement proceedings.
16. Eligibility: The brokers shall comply with the criteria set under the conditions of contract as well as guideline attached herewith.
