The Commission with the prior approval of the Government, has amended/changed the following clauses of “Regulatory And Licensing Guidelines For Invitation of Proposals/Offers For Issuing License For Establishing, Operating And Maintaining of Broadband Wireless Access Services in Bangladesh” bearing No. BTRC/LL/BWA(275)/2008-1033, Dated:06-08-2008. The amendments/changes are as follows:
