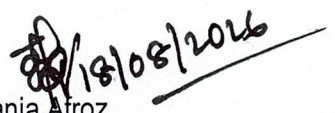
2. The tour will be subject to the following conditions:

3. All expenses of Mr. Nur Mohammad Hossaini, Deputy Secretary, Cabinet Division, will be borne by the 'E-effective Governance' project, funded by the European Union. No part of the expenses shall be borne by the Government of Bangladesh (GoB).

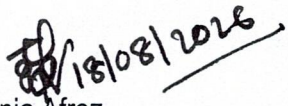
