1. Container Company of Bangladesh Limited (CCBL), a fully government-owned enterprise entrusted with the management, operation, and development of Bangladesh Railway's container transportation business, including existing and future rail-based Inland Container Depots (ICDs) nationwide, hereby invites applications from competent, dynamic, and experienced Bangladeshi nationals for appointment to the position of **Managing Director** on a contractual basis. The job responsibilities, eligibility criteria, required qualifications, experience, and remuneration package are outlined below :
 - A) **Remuneration Package (Monthly):** Basic pay Taka 97,500/- (ninety seven thousand five hundred) Plus house rent @ 50% of basic pay, two festival bonuses in year, Bangla new year allowance once in every year @ 20% of basic salary, Medical Allowances Taka 2,000/- (two thousand) and other admissible allowances and facilities as per applicable rules of the company. Income tax shall have to be paid by the employee. This remuneration / compensation package will be subjected to adjustment in the pay structure of the company.
 - B) **Educational Qualifications:** Master's Degree in any discipline, preferably in Business Management, Logistics Management, Business Administration or any closely related discipline with no third division/ class in any public exam. Training on i) ICD Management ii) Port Operation/ Management iii) Container Handling iv) Logistics Management v) Multimodal Transport System vi) Good Governance vi) Project Management will be treated as additional qualification.
 - C) **Job Experiences:** Minimum 15 (fifteen) years of experience in operation Management, Port Management and/or Logistics Management including at least 7 (Seven) years of experience in Senior Management Position in any reputed Public/Private organization having proven track record.
 - D) **Key Responsibilities:** Report to the Chairman and the Board of Directors of the Company and accountable for the Company's entire day-to-day operations, profitability and growth. The Managing Director is the Chief Executive of the company. Subject to the supervision and approval of the board, the managing Director will be responsible for overall management, e.g. i) Strategic Management ii) Develop Operation Management iii) Human Resource Management iv) Relationship Management v) Strategic Risk Management vi) Safety, Security & Quality Management vii) Compliances and Corporate Governance viii) Other Essential Functions of the company.
 - E) **Age Limit:** Between 50-65 years of age as on 30/07/2026.
 - F) **Tenure of Appointment:** The **Managing Director** will be appointed on a full time contractual basis initially for a period of 02 (two) years which may renewable on satisfactory performance subject to approval of the Board of Directors.
