

**Office order**

The undersigned is directed to convey the sanction of the Government of the People's Republic of Bangladesh for 42 (forty-two) months of deputation in favour of Md. Monjurul Huda, Cotton Development Officer, Cotton Development Board, Dhaka to study the Doctor of Philosophy (PhD) course under the Texas Tech University, Lubbock, USA from the date of charge handover under the following terms and conditions:

- a) While studying in the PhD course and journey from USA, he will be treated as on deputation;
- b) He will draw his pay and allowance in local currency; no part of it shall be drawn in foreign currency;
- c) Before going abroad, he will give the bond following the rules;
- d) The duration of the scholarship will be a maximum of 42 months;
- e) Expenses related to PhD study will be borne by Partner, APCU-BARC;
- f) The candidate will not eligible to receive any scholarship from other sources during the study period;
- g) He will submit a yearly progress report with attestation of the related supervisor through the proper authority to the Agriculture Ministry of Bangladesh;
- h) He must submit a final copy of dissertation/thesis and PhD at the Ministry of Agriculture and CDB immediate after completion of the PhD program; and
- i) The other rules of government related to the deputation will apply here.

2. This order is issued with approval of the competent authority.


