S.R.O No.374-Law/2013.—In exercise of the powers conferred by sub-section (1) of section 35 of the Ports Act, 1908 (Act No. XV of 1908), the Government is pleased to direct that fees for pilotage of the vessels within the Chittagong Port and Pangaon Container Terminal (PCT) shall be charged as follows:

#### PILOTAGE FEES

Pilotage fee shall be charged @ Tk. 5.500/- per trip (inward or outward).

**Notes:** (i) of this rate tk. 4,000/- shall be applicable from Chittagong Port to outer anchorage and vice versa.

(ii) of this rate tk. 1,500/- shall be applicable from outer anchorage to PCT and vice versa.

(iii) outer anchorage to PCT and vice versa rate shall be changed as and when fixed by Bangladesh Inland Water Transport Authority (BIWTA).

S. R. O 375-Law/2013.—In pursuance of the powers conferred by section 19 of the Chittagong Port Authority Ordinance, 1976 (Ordinance No. LII of 1976), Chittagong Port Authority, with the approval of the Government, is pleased to frame the following charges for the Pangaon Container Terminal (PCT), namely :—

**Tariff Item No. 1**

**TUGS**

Tug charge shall be @ Tk. 5,000/- Per Movement (Inward or Outward).

**Notes:**

- (i) Tug assistance is mandatory during inward and outward Pilotage movement at both side i.e. Chittagong Port & all other Inland Container Terminal (s).

(ii) In addition to the usual charges the party requisitioning the use of the Tug shall be liable to pay reasonable compensation for any damages caused to the Tug in rendering the assistance required. Such compensation shall be determined by the Chairman / Chittagong Port Authority (CPA).

#### **Tariff Item No. 2**

##### **BERTHING OR UNBERTHING**

Berthing or Unberthing Charges shall be @ Tk. 1,500/- Per occasion.

Notes :

- (i) Occasion means for the purpose of this tariff item movement to or from berth.
- (ii) This tariff shall be applicable only for Vessels berthed or unberthed at Chittagong Port and Pangaon Container Terminal (PCT).
- (iii) This service may be carried out by launch or hawser boat or heave up boat or mooring boat.

#### **Tariff Item No. 3**

##### **BERTH OCCUPANCY**

Berth hire Charges shall be @ Tk. 1,000/- Per vessel, per hour or part thereof.

Notes :

- (i) Berth hire shall be minimum Tk. 5,000/- Per vessel.
- (ii) Vessels which do not vacate the berth after receiving written notice to do so from the CPA / PCT authorities, shall be charged ten times of the rate shown for the period after receiving the written notice.
- (iii) This service includes the mooring gangs necessary for the berthing and unberthing operations.

#### **Tariff Item No. 4**

##### **WATER SUPPLY CHARGES**

Water Supply to a vessel by means of the main supply line shall be charged @ Tk. 150/- Per 1000 liters or part thereof.

- (iii) The Master, Owner, or Agent will supply their own slings and the jetty authorities shall accept no liability for the same.
- (iv) The jetty authorities may at their discretion ask a vessel to work on holidays and vessels failing to comply with the same may not be allowed to remain on a jetty/terminal berth.

For LCL, this tariff covers the movement of container between jetty and storage area and to & from the point of stuffing/unstuffing, extra movements, such as stacking or restacking carried out for PCT convenience are included.
- (ii) Over height containers shall be charged at one and a half times the loading or discharging rate. Over height containers are in excess of nine feet high.
- (iii) Open top or Flat or Side open or Over Weight or Over Dimensional empty container / such loaded container having projected cargo shall be charged at two times the loading discharging rates.
- (iv) Due to non-availability of PCT equipment if Authority asks any Shipping Agent/Owner of the vessel to use their own equipment to assist in loading or discharging, the charges shall be 70% of the rates shown. This is applicable for handling of container from hook point to container yard and vice versa in PCT protected area. For LCL loading/discharging, this rebate shall be given on the basis of FCL rate shown.

- (i) This tariff covers the movement of FCL or empty container between hook point and PCT storage point and vice versa. For LCL, this tariff covers the movement of container between jetty and storage area and to & from the point of stuffing/un-stuffing, extra movements, such as stacking or restacking carried out for PCT convenience are included.
- (ii) Over height containers shall be charged at one and a half times the loading or discharging rate. Over height containers are in excess of nine feet high.
- (iii) Open top or Flat or Side open or Over Weight or Over Dimensional empty container/such loaded container having projected cargo shall be charged at two times the loading or discharging rates.
- (iv) Due to non-availability of PCT equipment if authority asks any Shipping Agent/Owner of the vessel to use their own equipment to assist in loading or discharging, the charges shall be 70% of the rates shown. This is applicable for handling of container from hook point to container yard and vice versa in PCT protected area. For LCL loading/discharging, this rebate shall be given on the basis of FCL rate shown.


