- 5.0 We request you to submit acceptance of this Notification of Award within 7 (seven) working days by furnishing a copy thereof duly countersigned and stamped on each page, including all the enclosed appendices, by the authorized signatory of the Contractor, as a proof of your acknowledgement and confirmation.
- 6.0 The provisions and stipulations, including the obligations and liabilities of the Contractor, as set out in the Bidding Documents, especially under Section-III (Conditions of Contract) of the Bidding Documents, shall apply to and in respect of this Notification of Award. Meeting Minutes of Pre-contract Negotiation shall supersede the related clauses of the bidding document.
- 7.0 Until the formal Contract Agreement is signed, this Notification of Award shall constitute a legally binding and enforceable Contract.
- 8.0 You shall prepare and finalize the Contract Document for signing of the formal Contract Agreement and shall enter into the Contract Agreement with us, as per the proforma enclosed with the Bidding Document, on non-judicial stamp paper of appropriate value within 30 (Thirty) days from the date of issuance of this Notification of Award.

You are required to take the necessary action to prepare for commencement of the Services and confirm action taken in this regard to CPGCBL.
