Terms and Conditions

1.	The tender validity period shall be 90 (Ninety) days from the tender opening date.
2.	Every page of the tender document shall be duly signed by the Tenderer.
3.	The tenderer must submit the proposal in a sealed envelope mentioning the name of the Tender at the top and clearly mentioning the tenderer's name & address (including Mobile Number) on the left side of the envelope. No tender will be accepted after the submission deadline.
4.	Interested person/firm may arrange site visit to inspect the mentioned scrap materials at their own cost with prior approval from CPGCBL. Site visit period is 13/05/2026 to 21/05/2026.
5.	The Tender Document to be filled properly and the quoted price shall be in Bangladeshi currency. Tenderer have to quote prices for all items of the price schedule clearly in figures and words. Non-quotation of any item will be considered as incomplete Tender and that Tender shall be rejected directly. Correction (if any) must be duly initiated by the tenderer.
6.	Evaluation has to be carried out based on total price of the Price schedule. The quoted price shall be excluding VAT, Tax. Successful Tenderer shall have to pay the total price of the scrap materials including VAT, Tax (in addition to the quoted/evaluated price) as per applicable law of Bangladesh.
7.	Mathematical errors (if any) shall be corrected to calculate the evaluated price. Tenderer is obliged to accept the mathematical corrections (if errors are found).
8.	Contract Price shall consist of the total evaluated price, VAT, Tax and other applicable charges/fees (if any). For selling of scraps through tender process, the current rate of VAT is 15% and AIT is 10% as per govt. rules. Existing rate during the contract signing shall be effective for determination of actual VAT & Tax (AIT).
9.	Within 14 (Fourteen) days of receiving the Letter of Intent (LOI)/Notification of Award (NOA), the tenderer (Purchaser) has to submit the rest amount (Contract Price - Tender Security) of the Contract Price (for payment option-1) or 1st installment (50%) (for payment option-2) as per payment schedule in the form of a Pay Order/Bank Draft in favor of "Coal Power Generation Company Bangladesh Limited". Otherwise, the full amount of Tender Security will be forfeited.
10.	In addition to this initial payment, within 14 (fourteen) days of issuing Letter of Intent (LOI)/Notification of Award (NOA), Taka 10,00,000.00 (Ten Lakh) only has to be deposited as Performance Security in the form of a Pay Order/Bank Draft in favour of "Coal Power Generation Company Bangladesh Limited" from any scheduled bank of Bangladesh. After successful completion of the delivery work this Performance Security money shall be returned upon certification from the delivery committee.
11.	While the 1 st payment (as per the payment schedule) is confirmed, a contract will be signed between CPGCBL and the successful tenderer (Purchaser). After the contract signing, Sell Order will be issued and the delivery timeline will be counted from the issue date of the Sell Order.
12.	The delivery must be completed within a total of 120 (One Hundred and Twenty) days period in all aspects. All Scrap materials must be taken by the purchaser, i.e. scrap yard should be cleaned.
13.	The materials shall be sold through the tender process based on their actual measurement. All materials shall be measured & delivered in the presence of the delivery committee. Purchaser shall use sufficient equipment (magnetic crane, excavator, drum truck, barge etc.) and manpower by their own arrangement to accelerate the delivery activities as per instruction of the delivery committee.
14.	At the time of execution of the contract or issuance of the sell order, if the delivery Committee finds that the quantity of materials exceeds the contract quantity, the additional scrap materials may be sold to Purchaser at the same rate as the original contract.
15.	Sold materials shall be received by the Purchaser upon following/ensuring any pass, gate pass, delivery challan and other obligations of CPGCBL.
16.	As Matarbari 2X600 MW Ultra Supercritical Coal Fired Power Project is a KPI project of the country, Purchaser must follow all security-related issues of the project during the delivery of scrap materials.



17.	The Purchaser at their own cost will perform all the activities of loading, transportation etc. while performing such activities. No damage to any properties of CPGCBL is acceptable. If such happens due to the negligence of the tenderer, they have to pay the full value of damaged properties as compensation.
18.	In case of any loss/damages of any people or materials due to an accident during delivery time/related activities, the tenderer has to bear all the responsibility and compensation to be paid by the tenderer as per applicable labor law of Bangladesh. CPGCBL will not be responsible for this matter.
19.	If the Purchaser fails to complete the delivery within the intended time, CPGCBL reserves the right to forfeit the performance security and the remaining materials as well.
20.	Rules & regulations of tender document and terms & conditions imposed from time to time by CPGCBL will be applicable.
21.	If the office remains closed on the last date of Tender Selling/Closing/Opening due to a government executive order or any other inevitable reason, then the last date is considered extended to the next working date.
22.	CPGCBL reserves the right to reject all the Tenders or annul the Tender proceedings at any time.
