THIS AGREEMENT made the 18th day of May, 2026 between **DHAKA ELECTRICITY SUPPLY PLC (DESCO)**, 22/B, Kobi Forrukh Sarani, Nikunja-2, Khilkhet, Dhaka-1229, Bangladesh (hereinafter “the Procuring Entity”) of the one part and **JV OF H. H. TRADERS, MORSHED ENTERPRISE & SM ENTERPRISES LTD.**, 44 Abdullahbagh, North Badda, Dhaka-1212 (hereinafter called “the Contractor”) of the other Part:

 - (i) the priced BOQ and the Schedules
 - (j) any other document listed in the PCC forming part of the Contract.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
