Subject: Invitation Notice to Join General Market Engagement Conference to be held on 26/01/2026 at 11.00 am at Korobi Conference Room, Ban Bhaban, Agargaon, Dhaka under the Strengthening Health Emergency Prevention, Preparedness, Response and Resilience with One Health Approach Project financed by the Government of Bangladesh and the World Bank.

We are pleased to inform you that the Government of Bangladesh is undertaking the Strengthening Health Emergency Prevention, Preparedness, Response and Resilience with One Health Approach Project financed by the Government of Bangladesh and the World Bank. The project objectives, among others, is to prevent, and respond to health emergencies by strengthening the capacity of human, animal, and environmental health systems in Bangladesh using the one health approach. Directorate General of Health Services (DGHS), Department of Livestock Services (DLS) and Bangladesh Forest Department (BFD) will jointly implement the project.

The project procurement will follow The World Bank's Procurement Regulations for Investment Projects Financing (IPF) Borrowers (Seventh Edition, September 2025). The project is expected to be approved very soon and the procurement of inputs for the project realization will commence from FY 2025-2026. As the process of designing fit-for-the-purpose Project Procurement Strategy for Development (PPSD), greater use of early stakeholder and market engagement to understand market context and get the right Suppliers, Contractors and Consulting Firms has been planned.

In view of the above, the Bangladesh Forest Department (BFD), on behalf of other two project implementing agencies Department of Livestock Services (DLS) and Directorate General of Health Services (DGHS), hereby invites interested private sector stakeholders and industry players (Suppliers and Contractors) to a Two-hour Consultation Meeting to be held at **11:00 AM on 26 January 2026 (Monday)** at Korobi Conference Room, Ban Bhaban, Agargaon, Dhaka; by sending representatives at top management level who have good understanding of the market and its firm experience. Please note that the general market engagement is relevant to the **Suppliers and Contractors** who have experience in supplying similar goods and/or constructing similar works with single contract value of minimum **US\$ 1 million** as follows:

- **Suppliers:** Medical & Lab equipment (DGHS); Lab equipment, reagents and consumables, testing kits (BFD & DLS); wildlife rescue equipment, furniture for lab, etc. (BFD); rabies vaccine, vaccination devices, etc. (DLS).
- **Contractors:** Construction of safe enclosure for housing of animals at wildlife safari park, etc. (BFD); construction and renovation of lab buildings (DLS).

The objectives of the meeting are to relay general information on the project to private sector stakeholders, present details of the procurement components, including nature of the procurement, delivery models, market approach, expected procurement packages and implementation arrangements, and receive feedback from vendors on the suitability and sustainability of the proposed project design.

The consultation is also to help to hear from the industry players as a process of market engagement and use the market information for project procurement strategy preparation.

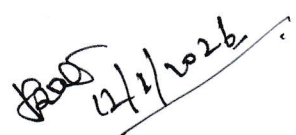
