In pursuant to the above letters, seeking Import Permit and Veterinary Protocol for the import of following wild animals from Mr. J.H. Pretorius, Mafunyane, P.O. Box 1539, Brits 0250, South Africa to Dulahazara Safari Park, Cox's Bazar, Chattogram, Bangladesh, Department of Livestock Services (DLS) is issuing this import Permit in favor of you for the following animals under the conditions mentioned below:

As per the country's Prevailing Veterinary Protocol, the animal must be vaccinated against Canine Distemper Virus (CDV), Feline Leukemia Virus (FeLV), Feline Corona virus (FCoV), Feline Immunodeficiency Virus (FIV), Feline Parvovirus, and must be free from Trypanosomiasis, Toxoplasma gondii and any other external or internal parasites. The following documents must accompany with the consignment:

1. Veterinary Health Certificate
2. Quarantine Certificate
3. Vaccination Certificate
