This NOC is not transferable and valid for 90 days from the date of issue.

Terms and Conditions:

1. This NOC is applicable only for domestic pigeons, not for wild pigeons.
2. All export-related rules and regulations must be followed.
3. The authority may cancel or suspend the NOC at any time for the public interest.
4. In the event of any breach of the above-mentioned terms and conditions or violation of existing government laws, the issued NOC shall be deemed void. Furthermore, any future applications may be considered ineligible, and appropriate actions will be taken in accordance with prevailing regulations.
5. Partial shipment is not allowed.
