Terms and conditions:

1. This Registration Certificate shall not relieve any of the statutory obligations of the concerned buying house. The buying house authority shall be responsible for any mishap caused by any breach of condition or failure to comply with the rules.
2. This Registration Certificate shall have no involvement in any financial transaction with national/international government or non-governmental financial organization in implementing the buying house.
3. If any changes happens in ownership or address of the buying house must be notified to the Department of Textiles immediately.
4. The registered buying house should extend their full support to any survey or inspection conducted by the government or collecting information.
5. The buying house authority should inform the Department of Textiles in case of the government privileges received.
6. Any officer and inspector of the Department of Textiles may visit the buying house at any time.
7. The buying house authority should maintain and provide training facilities for internship training for the students of textile educational institute of the Department of Textiles.
8. Bangladesh labor Act 2006 should be followed. Child labor should not be employed in any circumstances.
9. The buying house authority must take appropriate security measures that are maintained by the existing laws of the country.
10. The authority shall have to provide Day care facilities, maternity leave facilities, and low-cost housing facilities for low-income female employees and payment of wages and also take measures for equal pay to the male and female employees in order to provide gender equality. In addition buying house should provide low cost food canteen facilities, peaceful working conditions between men and women employees.
11. The Department of Textiles will not be liable for any land acquisition related with the concern buying house.
12. The registration certificate may be revoked, suspended and altered either in part or whole and new condition be added at any time without assigning any reason thereof.


