Rear 3-4th RHS View



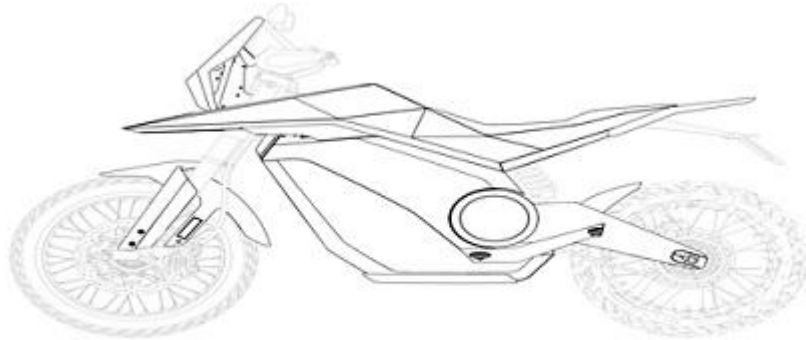
