Request for Expression of Interest for Engagement of Procurement Specialist

Government of the People's Republic of Bangladesh has received loan from the World Bank (with co-financing from Asian Infrastructure Investment Bank -AIIB) to finance Rural Water, Sanitation & Hygiene for Human Capital Development Project and intends to engage part of the proceeds for Procurement Specialist services.

The Department of Public Health Engineering (DPHE), under the Ministry of Local Government, Rural Development and Co-operatives, Government of Bangladesh, now invites eligible applicant ("Consultant") to indicate their interest in providing the Services as Procurement Specialist. Interested individual should provide information demonstrating that they have the required qualification and relevant experience to perform the Services as follows.

Duration of the consultancy services will be 60 months or project closing date or credit/loan closing date, whichever is earlier. In addition to that softcopy of REOI will require to be submitted in CD/DVD or flash drive or through email.

Any interested applicant who has an on-going contract in the World Bank Financed Project with a duration of more than 6 months from the last date of EOI submission, will not be considered for short listing.
