**Request for Expressions of Interest

The Department of Public Health Engineering (DPHE), under the Ministry of Local Government, Rural Development and Co-operatives, Government of Bangladesh, now invites eligible applicant ("Consultant") to indicate their interest in providing the Services as Financial Management Specialist.
