1. The People's Republic of Bangladesh has received financing from the Islamic Development Bank (IsDB) towards the cost of Integrated and Inclusive Sanitation and Hygiene Project in 10 Priority Towns Project and it intends to apply part of the proceeds toward payments under the contract for BAG-W1.

The Executive Engineer, DPHE, Bagerhat District, Bagerhat now invites online bids from eligible bidders for Supply and Installation of Point source tube-wells, Construction of Household water Connection & Street hydrant ("the Works") as detailed below. The works will be implemented in Bagerhat Pourashava, Bangladesh.

Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in IsDB's Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing, April 2019 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.18 -21 setting forth IsDB's policy on conflict of interest.
4. This is an online bidding (e-Tendering) where only e-Tender (e-Bid) will be accepted in the Bangladesh National e-GP System Portal and no offline/hard copies will be accepted. To obtain further information and to submit e-Tender for the above works, registration in the e-GP portal (<http://www.eprocure.gov.bd>) is required.
5. The fees for downloading the e-Tender Documents from the e-GP portal, and the tender security as mentioned in the documents shall have to be deposited online through any branch of the banks registered in the e-GP system.
