

**Sub: Amendments to the Bidding Document against Contract Package No. URBAN-GD-5 for Procurement of 51 nos Desludging Truck (Different Size).**

**Amendment-1**

The Bidding Document issued against Memo No. 46.03.2600.026.07.023.22-1418 dt. 27.11.2025 is hereby amended as follows as per ITB Clause 8:

Reference to the Section of the Bid Documents	Proposed Amendment
Section III 3.1 Evaluation and Qualification Criteria (ITB 37.1)-b): if bidder is not manufactured	<p>The criteria 3.1-b) is amended as below:</p> <p style="padding-left: 40px;">If a Bidder is not a manufacturer, but is offering the Goods on behalf of the Manufacturer under Manufacturer's Authorization Form (Section IV, Bidding Forms), Bidder shall demonstrate that it has successfully completed at least (a) <b>1 (one) contract</b> of similar goods [Truck/Trailer/Pickup/ Desludging Truck with accessories and related services] of <b>Value BDT 134 Million OR (b) 2 (Two) contracts</b> of similar goods [Truck/Trailer/Pickup/ Desludging Truck with accessories and related services] of <b>each with a Value BDT 67 Million</b> in the past five years.</p> <p>The Bidder shall furnish documentary evidence to demonstrate that the Goods it offers meet the following usage requirement: technical specification catalog of product (brochures). The minimum amount of liquid assets or working capital or credit facilities of the Bidder shall be BDT 178.60 million Only. In case of JV this value shall be met by the members in combined.</p> <p>The Bidder shall demonstrate that it has successfully and substantially completed similar goods and related services under one or two contracts. For joint venture, these requirements in number of contracts shall be met by all members in combined but value of individual contracts shall not be added. In order to demonstrate it meets the experience requirement, the Bidder shall furnish detailed information regarding contracts competed: the purchaser's name and address, country, name and object of the contract, scope of</p>



	services, date of contract completion, equipment supplied, contract amount, contract role (prime supplier, subcontractor, partner in joint venture) and percent of the contract value undertaken by subcontract.

In view of these above amendments the relevant provisions shall be read and interpreted accordingly amended elsewhere in the Bidding Document.

All other terms and conditions of the issued Bidding Document shall remain unchanged.
