The Executive Engineer, DPHE, Tangail Division, Tangail, Bangladesh now invites sealed bids from eligible bidders for the **Installation/Construction of 4 Test tubewells, 2 Production tubewell, 3 Pump Houses, 60 water points, Submersible Pump Procurement with Column Pipe, Electric Panel Board Installation etc., electrification with transformer, 1 Ground Water Treatment Plant & 1 Overhead Tank** under “Urban Water Supply and Sanitation in 23 Pourashavas Project in Bangladesh” (“the Works”). The works will be implemented in Ghatail Pourashava of Tangail District, Bangladesh.
