The services include Audit of Project's Financial Statement and preparation of its Report. Interested consultants who has experience of auditing specifically preparation of audit report for at least two project funded by Multi-Development Banks or any international organizations shall be the minimum requirement for the assignment and consultant must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).

Local consultants may express interests in the form of association, validated by an agreement among members of the association which clearly specifies the type of association, i.e. a Joint Venture(s), intermediate forms of association, or sub consultancy.

A consultant will be selected in accordance with the procedures set out in the Guidelines for the Use of Consultants under Islamic Development Bank Financing (current edition) using Least Cost Selection (LCS) method.
