In addition, please refer to 1.9.1-1.9.5 paragraphs of the Procurement Policy of the Procurement Guidelines setting forth IsDB's policy on conflict of interest.
4. This is an online bidding (e-Tendering) where only e-Tender (e-Bid) will be accepted in the Bangladesh National e-GP System Portal and no offline/hard copies will be accepted.
