The consultants shall have to submit their EOIs electronically through the ADB CMS by **11:59 PM (Manila local time) on 26 April 2026**. 7. The individual consultant will be selected in accordance with the Individual Consultant Selection (ICS) method following the Procurement Directive for ADB Borrowers, effective from 1 January 2026.
8. The Consultant's contract award and signing will be subject to ADB's concurrence. The EOI submitted by a consultant will be rejected if he/she has been debarred by GoB or by the ADB.
