This is to notify all concerned that, in response to queries received from prospective tenderers and upon review of the tender document, the following clarifications and corrections are hereby made:


**Clarification & Correction Table**

Sl. No.	Query Description (as raised by Tenderer)	Response of Procuring Entity (PE)
1	Clarification is sought whether a side table will be included for Item No. 1 & 2: Full Secretariat Table (Category-2 & 3).	Item No. 1 & 2: Full Secretariat Table (Category-2 & 3) shall be supplied with side table and drawer unit as integral parts of the set. The side table (L-1200 × W-600 × H-760 mm) shall be provided with an integrated drawer unit, proportionately designed and incorporated within the side table structure.
2	Clarification is sought whether a movable drawer will be included for Item No. 3: Office Table (Staff).	The dimension of the Office Table was stated as L-1600 mm in the tender document; however, the correct dimension shall be L-1200×W-750×H-750 mm. A drawer unit (size: 400 × 480 × 700 mm) shall be included with the table.
3	Clarification is sought regarding the configuration of Item No. 13: Sofa Set (whether it is 2+2+1).	The configuration of the sofa set shall be 2+2+1 (two 2-seater sofas and one single-seater sofa).

The above clarifications and corrections shall form an integral part of the Tender Document.
