- iii) in accordance GCC Sub-clauses 32.1 of PCC of the draft Contract Agreement duly initialed by both parties, A Non-Disclosure Agreement (NDA) will be signed with your Firm. However, The NDAs (for further details refer to Attachment-2) will be signed before the signing of contract agreement. In this regard for further details refer to Attachment-1.
- iv) sign the **Contract Agreement** within **21 (Twenty-One) calendar days** of issuance of this NoA pursuant to PPR-2008 Rule-102(11).

Your firm may proceed with the execution of the assignment titled "DTCA Clearing House Operation and Maintenance" after completion of the above tasks. You may also note that, this NoA shall constitute the part of the Contract, which shall become binding upon you.
