The name of the Tender and the number and identification of its constituent lot(s) are stated in the <b>TDS</b>.</li> <li>• The successful Tenderer shall be required to complete the delivery of the Goods and related services as specified in the General Conditions of Contract.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>Interpretation</b></li> </ul>	<ul style="list-style-type: none"> <li>• Throughout this Tender Document the term “in writing” means communication written by hand or machine duly signed and includes properly authenticated messages by facsimile or electronic mail:               <ul style="list-style-type: none"> <li>• if the context so requires, singular means plural and vice versa; and</li> <li>• “day” means calendar days unless otherwise specified as working days</li> <li>• “Person” means and includes an individual, body of individuals, sole proprietorship, partnership, company, association, or cooperative society that wishes to participate in Procurement proceedings.</li> <li>• “Tenderer” means a Person who submits a Tender.</li> <li>• "Tender Document ", means the Document provided by the Procuring Entity to a Tenderer as a basis for preparation of its Tender;</li> <li>• "Tender", depending on the context, means a Tender submitted by a Tenderer for delivery of Goods and Related Services to the Procuring Entity in response to an Invitation for Tender ;</li> </ul> </li> </ul>

- **“collusive practice”** means a scheme or arrangement between two (2) or more Persons, with or without the knowledge of the Procuring Entity, that is designed to arbitrarily reduce the number of Tenders submitted or fix Tender prices at artificial, non-competitive levels, thereby denying the Procuring Entity the benefits of competitive price arising from genuine and open competition;
- **“coercive practice”** means harming or threatening to harm, directly or indirectly, Persons or their property to influence a decision to be taken in the Procurement proceeding or the execution of a Contract, and this will include creating obstructions in the normal submission process used for Tenders.
- **“Obstructive practice”** (applicable in case of Development Partner) means deliberately destroying, falsifying, altering or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede an investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and /or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation.
- Should any corrupt, fraudulent, collusive, coercive (or obstructive in case of Development Partner) practice of any kind is determined by the Procuring Entity or the Development Partner, if applicable, this will be dealt in accordance with the provisions of the Public Procurement Act and Rules and Guidelines of the Development Partners as stated in the ITT sub-clause 3.3.
