Inviting Applications (Online) for CIP (Export)-2027

Export Promotion Bureau invites applications (online) from exporters/entrepreneur of an export-oriented company in Bangladesh (both domestic and foreign) for selection of **CIP (Export)-2027**.

02. According to the CIP (Export) Policy-2023, the product and service sectors are divided into 35 categories/sectors. Sector-wise Minimum export earnings for the fiscal year 2025-2026 (million US dollars) are as follows:

03. Information on the **CIP (Export)-2027** can also be collected from all offices of EPB & its website (www.epb.gov.bd), Chambers/Associations, BEZA and BEPZA offices.

Application can only be submitted online from 01 August to 31 August, 2026.

04. The following up-to-date certificates/documents must be attached with application:
(a) Certificates against payment (FY2024-2025) of Income Tax (Person & Company), (b) Certificates against payment of Value Added Tax (VAT), (c) Declaration in company's letter head pad confirming that it is not default in loan and money laundering case(s); (d) Main copy of Proceed Realization Certificate (PRC); (e) Up-to-date Certificate from the Department of Environment (If Applicable); (f) Original copy of one page Proceeds Realization Certificate (PRC) on the letterhead of the concerned bank stating the name of the company, name of the exported product and repatriated value (in million US dollars) at FOB price (FY2025-2026); (g) The Deemed/Partially Deemed exporting companies must be submitted one-page original PRC copy & along with E-PRC to the as per the format prescribed by Bangladesh Bank; and (h) Other information/documents as per the requirement of the online application form.
05. The companies belonging to a group under the same ownership and export the same category of goods or services, one authorized person can apply on behalf of the group along with the Certificate of Incorporation stating the export income of each unit of the group stating the product details.
06. A business entity/organization exporting more than one category of product or service has to submit application separately. That is, the applicant cannot show export earnings of one sector to other sector or together in the same sector. False/Erroneous information is not acceptable in any case. Applications with such information will be treated as invalid.
07. The PRC submitted will be verified with the database of Bangladesh Bank's Online Export Monitoring System (OEMS). As a True Single Source, the export income of the applicant found in OEMS, will be considered as authentic and final.
08. **CIP (Export)-2027 application must be submitted on online system. Hard copy of applications will not be accepted. The last date of submission of application is 31 August, 2026.** For more information, please contact the undersigned during office hours.
