

The Government of the People's Republic of Bangladesh (GoB) has received a credit from the International Development Association (IDA) towards the cost of coordinating and supervising of 12 components of the ISO and HELP projects under the **CCU of ISO and HELP Project, ERD** being implemented by the Economic Relations Division and intends to apply part of the proceeds of this credit for the services of an individual Consultant i.e. titled **"Project Manager: Administration & Operations"**.
2. **Scope of Services:** The Scope of Services of the Consultant includes, but not limited to (a) Overall Coordination and Supervision on Project Implementation; (b) Project Implementation Support; (c) Preparation of Workplan; (d) Monitoring and Evaluation (M&E) of the Project; (e) Sustainability and Capacity Building Program; (f) Training Provision and Support; (g) Reporting and Documentation; (h) Technical Advice to PD; and (i) Miscellaneous
3. **Duration:** The duration of the consultancy services is tentatively 33 months or till June 2028 from the date of the signing of the contract.
4. **Academic Qualification:** A master's degree in social science(s), Statistics, Economics, Development Studies, Public Administration or a related field. Equivalent combination of bachelor's degree in the above areas with relevant work experience in project management will be considered.
5. **Experience:** (a) Minimum of 7 years of experience in project management and coordination, preferably in humanitarian or development contexts; (b) Expertise in working with multi-stakeholder projects involving government agencies, international organizations, and NGOs; (c) Experience in programme planning, design, follow-up, report writing, monitoring and evaluation of the project; (d) Experience in donor-funded projects would be an advantage; (e) Excellent communication, negotiation, and facilitation skills and good ability to communicate in English.
6. Applicants are required to submit their Expressions of Interest (EOI), comprising of a CV (including employment history with duties and responsibilities) and a forwarding letter describing briefly the reasons that the applicant considers him/herself best suited to perform the assignment.
